



AGREEMENT
on cooperation between
State University "Uzhhorod National University"
and
"Vasile Goldiș" Western University of Arad

State University "Uzhhorod National University" (Ukraine 88000, Uzhhorod, 46 Pidhirna Str.) represented by Rector, Prof.dr. Volodymyr Smolanka, which acts on the bases of Statute from one side

and

the "Vasile Goldiș" Western University of Arad (94 Revoluției Blvd., 310025, Arad, Romania) represented by Rector, Prof.dr. Coralia Adina Cotoraci, from the other side, hereinafter referred to as "Parties",

Agree to stimulate and mutually support cooperative relationships, which will emphasize the development of collaborative educational and research projects.

Parties will encourage direct contact and cooperation between their faculty members, departments, and other research centres subject to the provisions of this Agreement.

1. Within the mutually agreed fields of study, "Vasile Goldiș" Western University of Arad and Uzhhorod National University agree to the following general forms of cooperation:

- Exchange of academic staff;
- Exchange of administrative and professional staff;
- Exchange of students, interns, trainees;
- Joint organization of courses, study tours, conferences and seminars;
- Organisation of Joint Master programmes and Doctoral Studies;
- Joint research projects, including applications for governmental and foundation funding;
- Other forms of cooperation of mutual interest.

2. Terms of joint activities, arrangements for specific visits, exchanges and other forms of cooperation will be negotiated for each specific activity. Any

financial arrangements will be negotiated and agreed upon separately in writing for each specific case and will depend upon the availability of funds.

3. Exchange of academic staff, research scientists, yearly quotas, duration of their stay will be defined in a separately prepared working programme. This working programme can be rearranged every year in accordance with the proposals of the Parties to meet the new demands and requirements.

4. The students, interns, trainees exchange will be regulated by the special agreement and/or the working programme between the institutions.

5. Parties state that the medical insurance expenses during the stay will be covered by participants in the exchange programme.

6. The Parties shall endeavour to resolve amicably all disputes and differences which may arise out of or in connection with the present Agreement through negotiations.

7. The present Agreement becomes effective upon the date of signing by the representatives of the Parties and is valid for five years. This agreement is automatically extended for a further 5 years if neither Party expresses a desire to terminate it 12 months prior to the expiration of the Agreement.

8. The Agreement was written in three copies in Ukrainian, English and Romanian languages, which have the same juridical force.
