

## **COOPERATION AGREEMENT**

between

**The Department of Political Science of State University `Uzhhorod National University`, the Institute of Ecological and Religious Studies of State University `Uzhhorod National University` (Ukraine) and the Chair of Christian Social Ethics, Faculty of Catholic Theology at Ludwig-Maximilians-Universität München (Germany)**

The Department of Political Science of State University `Uzhhorod National University`, represented by the head of the Department Prof. Mykola Vehesh, the Institute of Ecological and Religious Studies of State University `Uzhhorod National University` represented by the Director Oleksander Bokotey, PhD, acting on the basis of the Statute of the State University `Uzhhorod National University` on the one side and the Chair of Christian Social Ethics, Faculty of Catholic Theology at Ludwig-Maximilians-Universität München represented by Prof. Dr. Markus Vogt agreed on the promotion and multilateral support of cooperation aimed at implementing a joint research project `Tolerance at the Borders of Europe`, which will be implemented as part of the support program `Strengthening cooperation with civil society in the countries of the Eastern Partnership and Russia` in the period from 01.04.2018 to 11.10.2019.

Both sides will strengthen direct contacts and cooperation between their faculties in accordance with the provisions of this Agreement.

1. Within the framework of mutually agreed research areas, agreed on common forms of cooperation:

- Conducting research aimed at supporting aspects of tolerance in social, cultural and scientific and political studies;
- Joint organization and holding of an international scientific and practical conference;
- Participation in seminars, target working groups and other scientific meetings (meetings);
- Conduction of educational work in the field of tolerance with different actors;
- Work with mass media and public organizations;
- Sharing experience between faculty and staff;
- Exchange experience with administrative and professional staff;
- Exchange experience between young people and students;
- Other forms of cooperation between partners taking into account mutual interests;

2. Each party will appoint a responsible person to coordinate activities related to this agreement. On behalf of the Chair of Christian Social Ethics, Faculty of Catholic Theology at Ludwig-Maximilians-Universität München the authorized person is Felix Geyer, on behalf of State University `Uzhhorod National University` – Vice-Rector, Prof. Myroslava Lendel, DSc.

3. Terms of joint activity, conditions for using the results obtained and arrangements for specific meetings, conferences, exchanges and other forms of cooperation will be discussed separately for each specific occasion.



4. The financial aspects will be agreed in writing for each specific case and will depend on funding opportunities. Financing may be based on individual contracts.

5. The exchange of experience between the faculty and the students will be governed by the working program between the partners.

6. The parties agree that the cost of health insurance for the duration of stay will be covered by the participants of the exchange programs.

7. The agreement comes into force on the day of signing by the representatives of both parties and is valid for the period of the project implementation.

8. The agreement is executed and signed in two identical copies in English. Both copies are authentic.
