

MEMORANDUM OF AGREEMENT

BETWEEN

THE FACULTY OF LAW OF UZHHOROD NATIONAL UNIVERSITY, UKRAINE

AND

THE FACULTY OF LAW, CANON LAW AND ADMINISTRATION OF

THE JOHN PAUL II CATHOLIC UNIVERSITY OF LUBLIN, POLAND

Through a mutual interest in developing educational and community linkages that transcend national borders, and with the commitment to contribute to the intercultural and international education of its students, faculty members, staff and other community members, **The Faculty of Law of Uzhhorod National University, Ukraine** and **The Faculty of Law, Canon Law and Administration of The John Paul II Catholic University of Lublin, Poland** accede to enter into a Memorandum of Agreement in different endeavors which are mutually beneficial to both Parties.

Article 1

Both Parties agree to the following:

1. the increase in their educational, cultural and scientific relationship through the sharing and transfer of educational materials, publications, course literature and instructional resources, including electronically transmitted information;
2. exchange of faculty members, staff and research scholars who could seek ways by which they could participate in and contribute to cultural and educational programs developed by both Institutions;
3. the development of overseas study programs for their students, faculty members, staff and other community members;
4. the organizing of joint academic activities such as conferences/seminars.

Article 2

The two Parties agree to identify areas of collaboration for the design of individual projects of academic collaboration under this Agreement. These projects shall be determined by mutual accord in writing within the framework of this document.

Article 3

Both Parties agree that all financial arrangements will have to be negotiated and mutually agreed, and will depend on the availability of funds. Article 4

This Agreement will have, from time to time, annexes attached to it with regard to the specific projects.

Article 4

Article 5

In order to facilitate the good management of this Agreement, both Parties shall nominate persons within their Institutions to be in charge of the individual projects.

Article 6

Matters arising in relation to the implementation of the joint academic projects shall be negotiated and dealt with between the two Parties on a case to case basis.

Article 7

The present Agreement becomes effective on the date of its signing and is valid for a period of three (3) years. The Agreement may be renewed upon mutual consent by both Parties.

Article 8

Any modifications to the present Agreement shall be undertaken by mutual decision in writing and such change/s shall start on a date agreed upon by both Parties.

Article 9

Either Party may terminate the Agreement by providing the other Party with six (6) months prior written notice. Program/s or activity/ies already approved by both Parties shall be allowed to be completed under the conditions of this Agreement. This Agreement may be revised, if desired, by both parties.
